 - (1) MERCURY Includes instruments, switches, and measuring devices that contain mercury.
 - (2) HAZARDOUS OR TOXIC WASTE As defined by federal, provincial or municipal laws.
 - (3) NON-LEAD ACID BATTERIES We only accept intact and undamaged <u>lead-acid</u> batteries. All other types, such as LI-ION, VRLAB, GEL, AGM or VRSLAB are not accepted.

 - (6) BATTERIES Lead-acid batteries are only accepted if casing is intact and undamaged.
 - (7) TRANSFORMERS Must be either dry or drained and properly documented.
 - (8) BARRELS & DRUMS Must be clean and dry, bear no hazardous warning labels, contain no residue and tops must be removed for inspection.
 - (9) MICROWAVE OVENS Magnetron unit must be removed.
 - (10) LIGHTING FIXTURES Ballasts, capacitors & bulbs must be removed.
 - (11) SCRAP CONTAINING ASBESTOS Asbestos must be removed in compliance with applicable regulations.
 - (12) SCRAP CONTAINING ASBESTOS Fluids, including cutting oils, fuels, coolants, antifreeze, hydraulic oils, and solvents, must be drained prior to delivery.
